## The Mount Shasta Ninety-Nines Aviation Scholarship

#### Purpose:

The Mount Shasta chapter of the Ninety-Nines International Organization of Women Pilots, Inc. is offering a \$2,000 scholarship to local women. The scholarship can be used by the recipient to obtain a private pilot license, light sport pilot license, or toward an advanced rating to further her pursuit of an aviation career.

### **Eligibility**

The applicant must be a resident of Shasta, Trinity, Siskiyou, Modoc, Tehama, Glenn or Butte County.

The applicant must have passed the written exam, have a current medical for Private Pilot, or have a valid California Driver's License for Light Sport Pilot before money is awarded, <u>but not necessarily before application</u>. If an advanced rating is the goal, the applicant must also have a current flight review and all prerequisite ratings for the rating she seeks before money will be awarded, but not necessarily before application. She must be a Mount Shasta Chapter 99s member as well as a Ninety-Nines International Organization of Women Pilots, Inc. member.

The applicant must be proficient in English.

### **Application Guidelines**

Go the Mount Shasta 99s website for the application and instructions. Make sure your application has the title "Mount Shasta 99s Scholarship" heading. Follow instructions on the application, and submit by email a digital copy to <u>leroselane@gmail.com</u> or a hard copy to Lerose Lane, 3160 Wisconsin Avenue, Corning, CA 96021.

#### Additional documentation required

- <u>Personal essay</u>. In no more than 1000 words, address the following topics: your personal interests, general goals, career goals, and aviation goals; any special qualifications you may have to pursue these goals; what sparked your initial interest in aviation; what aviation-related activities you have participated in (including employment) that mean the most to you; how this scholarship will help you achieve your goals; any obstacles you have had to overcome to start in and continue in flying; and how you would contribute to the Ninety-Nines and to the aviation community in general.
- 2. <u>Budget Information</u>. Please provide a budget of anticipated expenses for the rating sought, anticipated funding to meet these expenses, and indicating whether you own or intend to rent an aircraft. The budget submitted should be signed by the flight school or independent instructor you plan to use to obtain the rating. The list of funds should include any other anticipated financial aid. If there are any special circumstances regarding your financial need, briefly list them.

#### TERMS

If the recipient does not complete the rating appropriate to her award within one year of the award date, her status will be reviewed. Special circumstances will be considered. Copies of her logbook shall be provided upon request, along with a status report from the instructor during this year. If her progress is not acceptable, all funds paid out must be reimbursed to Mount Shasta Ninety-Nines Aviation Scholarship fund within 60 days of that decision. The scholarship funds will be paid directly to the flight school or independent flight instructor conducting the training. Receipts showing hours flown and signed by both student and instructor must be submitted before funds are awarded.

# **INSTRUCTIONS TO APPPLICANTS**

**1.** The applicant must be a resident of Shasta, Trinity, Siskiyou, Modoc, Tehama, Glenn or Butte County, and a member of The Ninety-Nines Inc. at the time of submitting their scholarship application. Please be sure to include your membership number on the Official Application.

OR

2. Applicant must submit a FULLY COMPLETED application packet for the scholarship.

b. Email fully completed application packet to <u>leroselane@gmail.com</u> A confirmation of receipt should follow within 48 hours.

Please review your application packet carefully to be certain that all required items are included in each packet. Completed scholarship application packets must be RECEIVED BYJULY 31, 2021.

Scholarship packets shall contain:

- Official application signed and dated
- Copies of all aviation certificates
- Copy of current medical certificate
- Copies of last 3 pages of your pilot log book, if applicable
- Typed descriptive essay (1000 words maximum)
- Personal resume (last 4 years)
- Two letters of recommendation (each letter one page maximum)
- Any other information as requested for this scholarship
- o Mail original hard copy packet, or email packet
- 3. Applicants are encouraged to apply for other flight training scholarships.

4. Please be sure to include your descriptive scholarship essay of 1,000 words or less addressing the following topics: aviation related activities in which you participate, your initial interest in aviation: your aviation career goals, and how this scholarship will help you in attaining those goals; also include any challenges or obstacles that you have to overcome to start or continue your flight training; how you plan to support the mission of The Ninety-Nines; what you feel uniquely qualifies you for this scholarship. Also, include any additional pertinent information to be considered.

5. Scholarship winner will be notified on or before August 7, 2021.

6. All award money will be paid to the training institution, or flight instructor. All training is to be completed by August 7, 2021. Progress reports shall be provided to the Mount Shasta 99s on request.
